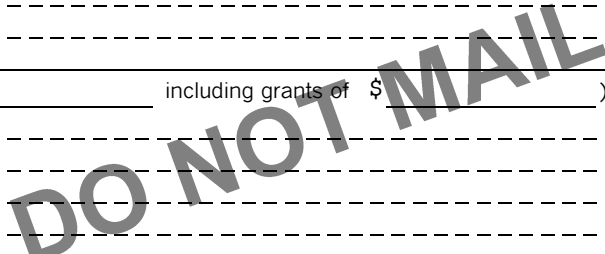

In 2021 the total number of services providing transportation for neighbors to healthcare and social service appointments; banking and pharmacy trips, visits to a family member in the hospital or a care facility and support group meetings number 6,123 which equates to 16,500 volunteer hours and 87,798 miles. Rides for grocery shopping with a neighbor numbered 835. These transportation service numbers indicate the significant impact PWC has on the health and well-being of community members by providing access to healthcare appointments, as well as for picking up their medications and groceries when they are unable to drive and need personal assistance during the trip.
